



## Nantucket Swim and Racquet Club Swim Waiver

I, being a full member(s) in good standing of the Nantucket Swim and Racquet Club (“NSRC”) and the adult member(s) of our household, do hereby voluntarily execute this waiver agreement. I/we have visually inspected the swimming pool area, understand the inherent risks involved in a swimming pool environment and promise to act in a responsible manner at all times, and assume the risk of using the pool and its surrounding areas. Except for any injury or damage resulting from the gross negligence or willful misconduct of NSRC, I/we on behalf of all members of our household, hereby waive all claim against NSRC and its members for any injury or damage sustained by while on NSRC property. I/we agree to abide by all current rules and regulations of the NSRC relating to the use and maintenance of its facilities and will require my/our guests to also abide by these rules and regulations. I/we also agree that I/we and my/our guests will abide by the following rules specific to this agreement. Please check the boxes after you have read and agree to each rule/regulation before signing. Anyone over the age of 18 in your household must sign the swim waiver agreement.

- No one is allowed to swim alone.
- At least one of the undersigned members, 18 and over, will be present at all times any members or guest of our household is using the NSRC facilities.
- All children of our household, and all our guests, who are under 18 will be constantly supervised by the undersigned.
- The pool and deck will be left in the condition in which they are found.
- The Pool Manager will be immediately notified of any damage, malfunction or vandalism of pool facilities. (Contact information is posted at the entrance gate and on the website [www. Nantucketclub.org](http://www.Nantucketclub.org))
- Pool conditions are not monitored after hours. It is possible that the water quality or facilities may become unsuitable for use during this time. The undersigned agree(s) to use good judgement to determine if the pool is suitable for use and to stop use if conditions are substandard. Further, the undersigned agree(s) to accept the liability to themselves and guests if substandard pool conditions exist.
- NSRC is a neighborhood pool. Noise during non-lifeguard hours will be limited to respect the rights of nearby residents.
- This privilege of pool use during non-lifeguard hours is awarded on a member-by-member basis, and any unacceptable behavior will result in the suspension and possible revocation of the undersigned’s access to the pool.
- The undersigned will abide by all decisions made by the NSRC board regarding all NSRC matters.
- All of the signing members have completely read and fully agree by and enforce the NSRC pool rules. (Posted at the pool and [www.nantucketclub.org](http://www.nantucketclub.org))
